#### RESOLUTION

RESOLUTION APPROVING THE ARGUMENT OF THE GOVERNING BOARD OF STANFIELD ELEMENTARY SCHOOL DISTRICT NO. 24 OF PINAL COUNTY, ARIZONA, IN CONNECTION WITH THE DISTRICT'S SPECIAL MAINTENANCE AND OPERATION BUDGET OVERRIDE ELECTION; AND RATIFYING ALL ACTIONS TAKEN OR TO BE TAKEN TO FURTHER THIS RESOLUTION.

Section 1. Approval. The Board hereby approves the argument "for" the Election attached hereto as *Exhibit A* and causes the same to be signed by the Board and submitted to the Pinal County School Superintendent for inclusion in the informational pamphlet.
