We need this bond to upgrade those areas.

New leadership is greatly improving curriculum to advance the education of our graduates and attract others from outside our district's limits to grow our student population.

It is necessary to prepare for the future growth expected with the increasing development to the south of AJ. Another elementary school requires planning so land must be purchased to mitigate overcrowded classrooms.

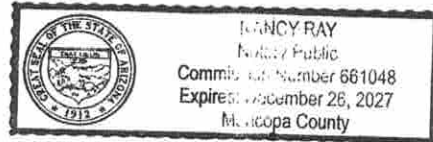
