The legislature has not adequately funded building/equipment maintenance and growth for many years. Our district has done an excellent job in recent years to maximize the funds available through the state ran School Facilities Board; and while this is a great start, it is not nearly enough. This severe gap in appropriate funding has caused deteriorating facilities, technology shortfalls, and unsafe security systems. We can do better than this for the children in our community. A YES vote on the AJUSD bond election, this November, will infuse our schools with the funding for much needed campus repairs and renovations, school buses, and more energy-efficient systems. It will also allow the district to plan for the growth coming to our community. By voting YES, we will send a clear message to our youth that they are important to us, they are worthy of our investment, and we believe in their future.

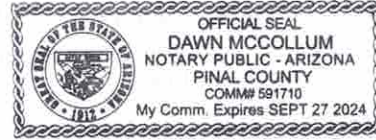
