Please join me in supporting the passage of the MUSD Bond Proposition 488.



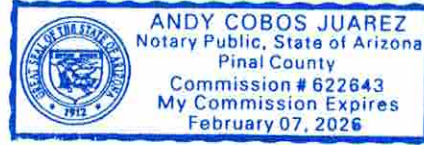
