Our community thrives when our schools thrive. Supporting this bond means creating opportunities for our children, attracting new families and businesses, and safeguarding our property values.



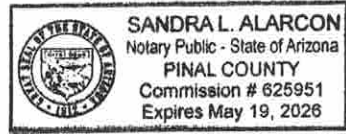
